Textual Information()

Note 1: In accordance with the Resolution Plan approved by the National Company Law Tribunal, Ahmedabad Bench (Approved Resolution Plan), Reliance Industries Limited (RIL) along with JM Financial Asset Reconstruction Company Limited acting in its capacity as a Trustee of JMFARC- March 2018 Trust- (JMFARC) have acquired joint control of the Company with effect from September 14, 2020. As a part of the Approved Resolution Plan, the Company had on February 28, 2020, allotted on preferential basis to RIL 83,33,33,333 equity shares of Re.1/- each at a premium of Rs.2/- per equity share for cash for a total consideration of Rs.250 crore and 250,00,00,000 - 9% Optionally Convertible Preference Shares (OCPS) of Re.1 each for cash at par, for a total consideration of Rs.250 crore. As per the terms and conditions of the OCPS, RIL was entitled to convert all or part of the OCPS into equity shares of the Company at any time on or before the expiry of 18 months from the date of their allotment, i.e. August 28, 2021. Since the option to convert OCPS into equity shares of the Company has not been exercised, the Company will now, as per the terms and conditions of the OCPS, redeem the same on the last day of the 10th anniversary of the date of allotment, such that the Company on redemption pays an amount equal at least to the outstanding OCPS Subscription Amount to RIL. Under serial no.2 of the Declaration tab i.e. Whether the Listed Entity has issued any Convertible Securities?, No is selected because the Company as on March 31, 2025 does not have any convertible securities. Further, in accordance with the Approved Resolution Plan, the Company on September 10, 2020, further allotted on preferential basis: i. 115,32,00,000 equity shares of the face value of Re.1/- (Rupee One only) each, fully paid up, to RIL, pursuant to conversion of debt. ii. 160,14,00,000 equity shares of the face value of Re.1/- (Rupee One only) each, fully paid up, to JM Financial Asset Reconstruction Company Limited acting in its capacity as a Trustee of JMFARC- March 2018 Trust- (JMFARC), pursuant to conversion of debt. Note 2: JM Financial Asset Reconstruction Company Limited, acting in its capacity as Trustee of JMFARC March 2018 Trust (JMFARC) is the persons acting in concert (PAC) with Reliance Industries Limited but considering that there is no provision for disclosing PAC with Promoter and Promoter Group in the prescribed format, they have been shown as part of the promoter group with an explanatory note. The details of shareholding of JMFARC are given below: JM Financial Asset Reconstruction Company Limited (acting in its capacity as Trustee of JMFARC March 2018 Trust) holds 1,73,73,11,844 equity shares, constituting 34.99% of the equity capital. Note 3: Voting rights are frozen on 30,540 equity shares held in the Unclaimed Suspense Account and 33,10,164 equity shares held by Investor Education and Protection Fund (IEPF).
